## **Project Description**

Colorado's Behavioral Health Administration (BHA) received federal funding from the Substance Abuse and Mental Health Services Administration's (SAMHSA) State Opioid Response (SOR) grant to help individuals in Colorado receive substance use disorder (SUD) treatment and services over the next two years. A provision of SOR funding requirement is the collection and reporting of performance data using the designated Government Performance and Results Act (GPRA) Client Outcomes Measures for Discretionary Programs Tool. This tool is used to survey clients seeking SUD treatment; collected data is then entered into SAMHSA's online portal. BHA has partnered with The Evaluation Center at the University of Colorado Denver to collect this federally mandated data for clients who are seeking SUD treatment or related services. To complete this effort, we are seeking student assistants to conduct data collection and entry. Data collection will be completed with individuals receiving SUD treatment through telephone interviews over the next eighteen months.

The primary role of this position is to assist in fulfilling the federal reporting requirement for the SOR grant; however, there are many opportunities to assist in other areas of the SOR evaluation. This position requires someone who is well organized, confident working independently and in teams, and communicates effectively with different audiences. Additionally, we are seeking someone who feels comfortable learning new technologies and conducting phone interviews. The Evaluation Center will provide the technology required for this work.

### Responsibilities include:

- Scheduling and conducting telephone interviews with clients receiving SOR treatment or services
- Entering data into online federal reporting system
- Tracking SOR client contacts and attempted contacts in internal database



- Reporting on data collection and entry status
- Building relationships with SOR clients
- Handling sensitive health information
- Coordinating with other team members via email and weekly team meetings

# Other responsibilities include, but are not limited to:

- Qualitative data analysis
- Quantitative data analysis
- Developing data summaries
- General support to other staff on SOR project
- Other duties as assigned

#### **Minimum Qualifications:**

- Currently pursuing undergraduate, Master's or Doctoral degree in public health, psychology, social work or a directly related field
- Experience with data entry
- Experience using MS Office, Google suite, and other relevant software

### Preferred Qualifications:

- Experience with basic data analysis
- Experience working with highly vulnerable populations
- Training and background in Trauma Information Practices, specifically Trauma Informed Interviewing

### Supervision Received

This position reports to Allyssa Mastroni, the GPRA Data Manager at The Evaluation Center.

#### Part-Time Effort Limits

Student Research Assistants are permitted to work up to 25 hours per week during Fall and Spring Semesters and 40 hours per week during Summer Semester. These hour limits apply to hours worked across *all* positions at the University. Student Research Assistant are paid starting hourly rate of \$19/hour with opportunities to earn \$21/hour within the first year. Within The Evaluation Center, schedules are determined based on project need and student availability to comply with the hour limitations stated above.

This position is will end at the conclusion of the SOR funding period (estimated September 2025). The GPRA Data Manager will establish expectations around schedule/hours and will approve all biweekly timesheets.
